

## **PRIVACY POLICY**

### **ART-C Agency Ltd. Concerts and Other Events**

#### **1. Scope of the Privacy Policy**

1. This Privacy Policy applies to all events and activities organized by ART-C Agency Ltd. and other concerts and events co-organized by ART-C Agency Ltd.

#### **2. General Rules**

1. Every event participant is obliged to familiarize themselves with this Privacy Policy and the information related to the Event.
2. The purchase of a ticket to an event implies acceptance of this Privacy Policy. Persons entitled to participate in the event free of charge (accreditations, invitations, contests, non-ticketed events, etc.) are required to comply with the provisions of this Privacy Policy to the same extent as event participants who have purchased a ticket.
3. The Privacy Policy is available at [address], at the entrance to the event venue, and on the website of the ticketing company (in the case of online ticket purchases): [websites].

#### **3. Age of Participants**

1. Participants must be at least 16 years old to attend events, except for events dedicated to children and young people up to 12 years old, and events for which the Event Organizer explicitly allows participation by individuals under the age of 16. Persons over the age of 16 may attend the event with written consent from their legal guardian. The Event Organizer informs that it does not collect or process personal data contained in the written consents mentioned above.

#### **4. Conditions of Entry**

1. Participants have the right to enter and stay on the event venue at the times and in the places designated by the Event Organizer.
2. Each participant of a ticketed event must present a valid admission ticket or another document entitling them to entry in the form specified by the Event Organizer before entering the event. The Event Organizer has the right to refuse entry to the event to persons without a valid and readable (also by scanning devices) admission ticket or another document entitling them to participate in the event.

#### **5. Identity Documents**

1. Event participants may be required to present an identity document.

#### **6. Tickets and Loss of the Right to Participate**

1. A purchased ticket should be treated as an individual consent given by the Event Organizer for the holder to participate in the event, which may be revoked at any time for reasons related to the need to maintain safety and order.
2. An admission ticket entitles the holder to a one-time entry to the event. Leaving the event venue (crossing the ticket scanning line) is considered a voluntary withdrawal

from further participation in the event, unless the Event Organizer or security services allow leaving the event venue during the event.

#### **7. Security Check**

1. Every event participant may be subject to a security check. Refusing to undergo a security check means voluntary withdrawal from participating in the event and the obligation to leave the event venue without the right to request a refund of the ticket price.

#### **8. Prohibited Items**

1. It is forbidden to bring the following items to the event venue: a. Weapons of all kinds (including cold weapons, knives, daggers, brass knuckles, etc.), b. Sharp objects such as knives, razors, box cutters, or umbrellas with a spike, c. Explosive, pyrotechnic, and flammable materials (including flags and banners with handles), d. Bottles, cups, cans, thermoses, and other containers made of glass, plastic, metal, or other materials (with the exception of plastic bottles and other containers approved by the Event Organizer for the event), e. Alcohol and drugs, f. Any audio/video recording equipment except for mobile phones and compact cameras with an optical zoom of up to 10x (unless the Event Organizer grants permission for this), g. Drinks and food.

#### **9. Deposit of Items**

1. The Event Organizer does not operate a deposit for items that are prohibited from being brought to and held at the event.

#### **10. Animals**

1. It is prohibited to bring animals to the event venue.

#### **11. Cyclists**

1. It is prohibited to bring bicycles to the event venue and leave them on the event premises unless designated areas are available.

#### **12. Large Items**

1. For safety reasons, it is not allowed to stay at the event venue with backpacks, suitcases, bags, sacks, etc., larger than A3 format, and other items that may affect the comfort or safety of event participants. These items, if available, should be left in the cloakroom upon request of the security services.

#### **13. Prohibited Items**

1. In the event of the detection of any of the above-mentioned items or any other item, the entry of which to the event venue may pose a threat to safety, breach of public order, and/or is prohibited by law, the Event Organizer and the security services have the right to refuse the holder of such an item entry to the event or demand their departure from the event. In the event of failure to comply with this order, they may be removed from the event venue without the right to a refund of the ticket price.

#### **14. Intoxicated Persons and Aggressive Behavior**

1. The Event Organizer has the right to refuse entry to the event or remove from the event venue intoxicated persons, persons under the influence of intoxicants, those displaying aggressive behavior, provoking aggression, not following safety rules and the regulations, or in any other way threatening their safety, the safety of other event participants, as well as the safety of artists, event staff, or event safety. In this case, there is no right to a refund of the ticket price.

#### **15. Organizer's Decision**

1. The final decision regarding the refusal to allow entry to the event or the removal of a participant from the event location belongs to the Event Organizer. In this case, the participant has the right to request an explanation of such a decision.

#### **16. No Smoking**

1. Smoking is strictly prohibited in indoor areas of the event (including electronic cigarettes).

#### **17. Property Protection**

1. It is forbidden to destroy information boards, trash cans, benches, and all other items and property, as well as to move devices and property located at the event venue without authorization.

#### **18. Provocation Prohibition**

1. It is forbidden to shout slogans that provoke or incite to disrupt order and safety, are offensive or demeaning to other persons based on their gender, race, religion, age, beliefs, or for any other reason.

#### **19. Blocking Evacuation Routes**

1. Blocking and obstructing exits and evacuation routes, access roads for rescue services, fire hydrants, and other necessary devices for rescue or firefighting during an event are prohibited.

#### **20. Reporting Threats**

1. An event participant is obligated to inform the Event Organizer or security services about any observed fire, threat to human life, health, or property.

#### **21. Property Responsibility**

1. The Event Organizer is not responsible for property left unattended at the event venue.

#### **22. Employee Recommendations**

1. An event participant is obliged to follow the recommendations of the Club's employees, the Event Organizer, and security services.

#### **23. Actions of Security Services**

1. The Event Organizer, in implementing the provisions of this Regulation, operates through the employees of the security service, who are entrusted with the task of ensuring safety and order during the event, as well as through other persons employed by the Event Organizer to service the event.

#### **24. Use of Direct Coercion Measures**

1. In the event of a violation of the provisions of this Regulation in a manner that may pose a threat to the safety of people and property and/or a violation of the law, the use of direct coercive measures is permissible for the purpose of apprehending, detaining, and transferring a person violating the law to law enforcement authorities or removing them from the event location. Employees of the security service who are security personnel are entitled to use direct coercive measures on the terms set out in Article 38 of the Act of August 22, 1997, on the Protection of Persons and Property.

#### **25. Reporting Violations of the Law**

1. The Event Organizer is obliged to inform the relevant authorities about detected violations of the law.

#### **26. Vehicles**

1. All vehicles parked at the event venue before and during the event without the appropriate permit for entry and parking will be towed at the owner's expense.

#### **27. Content and Form of Artistic Communication**

1. The Event Organizer is not responsible for the content and form of artistic communication presented during the event.

#### **28. Image Recording**

1. By participating in the event, the participant understands and accepts that they may be exposed to continuous exposure to sound intensity that may cause hearing damage, as well as exposure to strong light stimuli. Persons suffering from migraines and other conditions whose symptoms may be exacerbated by these stimuli (e.g., epilepsy) independently decide whether to participate in the event and cannot make any claims against the Event Organizer for this reason.

#### **29. Consent to Image Recording**

1. By participating in the event, the participant consents to the recording of their image by accredited photographers or camera operators in connection with their participation in a public event. The participant consents to the use by the Event Organizer of the image recorded in connection with participation in the event for an unlimited period of time and territory, as well as the use and disposal of the participant's image (photographs, videos, audiovisual materials, sound materials) recorded in connection with the event. The Event Organizer is obliged to ensure that the use of the image does not infringe on the personal rights of the persons whose image was recorded during the event.

#### **30. Penalties**

1. Failure to comply with an order given on the basis of the Act, the facility (venue) regulations, or the mass event regulations by the security services or information services shall be subject to a penalty of restriction of liberty or a fine of not less than PLN 2,000.
2. Persons who, during the mass event, stay in a place not intended for the public shall be subject to a penalty of restriction of liberty or a fine of not less than PLN 2,000.
3. Persons who do not comply with an order issued by the Police or the Military Police at the venue and during the mass event shall be subject to a penalty of restriction of liberty or a fine of not less than PLN 2,000.
4. Anyone who introduces or possesses alcoholic beverages at a mass event contrary to the provisions of the law shall be subject to a penalty of restriction of liberty or a fine of not less than PLN 2,000.
5. Anyone who introduces or possesses weapons at a mass event, within the meaning of the Act of May 21, 1999, on Weapons and Ammunition (Journal of Laws of 2004, No. 52, item 525, as amended), pyrotechnic articles, fire hazardous materials, or other dangerous objects or explosive materials at the mass event, shall be subject to a fine of not less than 180 daily rates, a penalty of restriction of liberty, or deprivation of liberty for a term of 3 months to 5 years.
6. Anyone who throws an object during a mass event that may pose a threat to the life, health, or safety of persons present at the venue or facility where the mass event is taking place or who disrupts the course of the event in any other equally dangerous way shall be subject to a fine of not less than 120 daily rates, a penalty of restriction of liberty, or deprivation of liberty for a term of up to 2 years.
7. Anyone who violates the physical integrity of a member of the security service or information service during a mass event shall be subject to imprisonment for a term of 3 months to 5 years.

### **31. Anti-Alcohol Trade Principle**

1. Transferring alcoholic beverages to a minor and delivering alcoholic beverages in a manner contrary to legal regulations is a crime. This offense is subject to criminal liability. By transferring alcoholic beverages to a minor, the supplier of alcoholic beverages exposes themselves to criminal liability, a fine, and imprisonment. The Event Organizer undertakes to carry out preventive and intervention measures against minors.

### **32. Controls**

1. Every person who enters the event venue is obliged to consent to inspection and inspection in accordance with the provisions of the Act on the Protection of Persons and Property.

### **33. Participant's Obligations**

1. The participant of the event is obliged to: a. Comply with the legal regulations in force at the event venue, b. Comply with the provisions of this Regulation, c. Exercise caution, ensure their own safety and the safety of other participants in the event, and

comply with the order and guidelines of the Club's employees, the Event Organizer, security services, and information services, d. Provide assistance to persons in need and report any irregularities to the employees of the Club, the Organizer, the security services, and the information services, e. Comply with the smoking ban in prohibited areas and maintain cleanliness and order at the event venue, f. Know the principles of first aid and provide it if necessary, g. Leave the event venue when the event ends or at the request of the Event Organizer or security services.

#### **34. Final Provisions**

1. The Event Organizer reserves the right to change this Regulation. Changes to the Regulation come into force on the date indicated by the Event Organizer, but not less than 7 days from their publication on the event's website.
2. In matters not regulated by this Regulation, the provisions of Polish law apply, and any disputes will be settled by the court having jurisdiction over the Event Organizer. This Regulation enters into force on the date of its publication on the event's website and applies from that moment in all matters related to the Event.
